

### Section 3 – External Auditor Report and Certificate 2017/18

In respect of **Market Rasen Town Council (LI0241)**

#### 1 Respective responsibilities of the body and the auditor

Our work **does not** constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and **does not** provide the same level of assurance that such an audit would do.

#### 2 External auditor report 2017/18

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review:

- The Council has not restated the prior year figures in Section 2, Boxes 2 and 3. As reported in the prior year External Auditor Report, these figures should read £94,793 and £67,473 respectively. All grants, including Council Tax Support Grant, should be shown in Box 3, as per the guidance notes on the AGAR.
