Key part of my role was communication, pubic meetings, awareness raising and education.

Budget responsibility was £7m per annum. Staff responsibility was 55 full time staff. Contractor management was for waste management services.

I set up and ran my own electrical engineering business employing 12 electricians before going in to local government.
